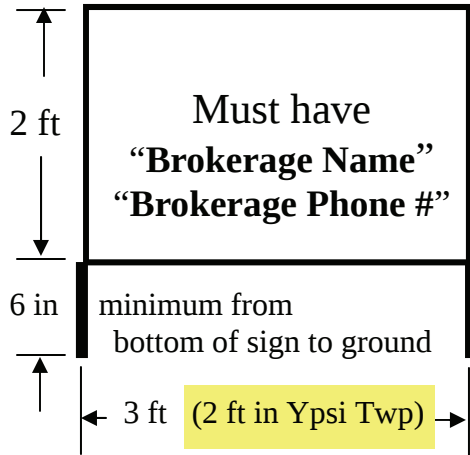


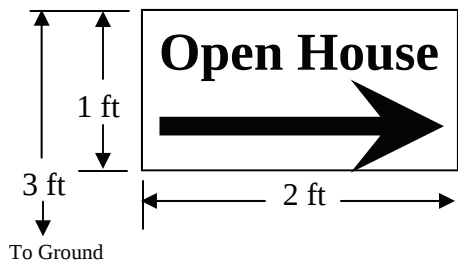
According to our research, the signs below comply with all Washtenaw County sign ordinances except as noted!

Please check the chart inside for other restrictions that may apply depending on the municipality the sign is placed in.



One sign per property
5 ft behind the sidewalk
Can not be placed in the "right of way"
Top of sign to ground not to exceed 4 foot
Removed within 3 days of sale

"Directionals"



Not all Twps. allow directionals.

The words "Open House" and an arrow only.

County	Washtenaw County Road Commision will remove and destroy any sign in the right-of-way of County and State roads.															

The one ordinance common to all: **Signs are not allowed in the right-of-way. PERIOD**

Where there are sidewalks, the right-of-way is between the street and the sidewalk.

Washtenaw County Road Commission defines right-of-way as:

33 ft. from center of a 2 lane road and

60 ft. from center of a 3 or 4 lane road.
